# Writing a winning entry – a three step guide!

### Choose the right category

Take the time to go through all the categories offered by this year's awards. Understand the categories and criteria to help you choose the one that best aligns with your project. Use the criteria of the category to structure your entry. Identify key words - these will indicate what the judges are looking for, so ensure you cover all essential points. Make sure each submission adheres to the specific criteria, especially if you are entering multiple categories.

### Tell a story

Share your story by outlining the objectives of your project, the challenges you faced, and the innovative solutions you implemented. Consider what you want the judges to learn about your business as they read your submission. Explain why you should win the award. Show how your project had a positive impact. Focus on your commitment to sustainability for both healthcare and the planet.

### Substantiate claims with supporting evidence

Use supporting evidence to further back up your written submission. This includes imagery, statements, floor plans, drawings, patient feedback, or any documents that can add value to your entry. Remember, judges habe many entries to go through, so keep it concise, and keep the word limit to under 500 words. Privilege quality over quantity.

### Patient Environment Class contains the following awards

### **BEST COLLABORATIVE ARTS PROJECT (STATIC)**

This award will recognise a traditional fine arts project that has had a measurable positive impact on the patient and staff experience within a health or care environment. Entries can include paintings, murals, light installations, sculptures etc - anything that is produced and displayed in its final state.

### **Entries must:**

- Provide an overview of the item or collection
- Explain how it improves the environment and/or patient experience, particularly if meant for a specific patient or resident group
- Explain how it was produced in close collaboration with staff, patients and other stakeholders
- Give an overview of how it was delivered sustainably and within budget
- Provide feedback from stakeholders

### **BEST COLLABORATIVE ARTS PROJECT (PERFORMANCE)**

This award will recognise a collaborative participatory arts project that has had a measurable positive impact on the patient and staff experience within a health or care environment.

## **Estates and Facilities Management contains the following awards**

### **BEST CARBON REDUCTION INITIATIVE**

This award reflects the recent challenge set by the Government for the NHS to become carbon-neutral by 2040. The judges will be looking for a single initiative, or series of initiatives, that are helping to reduce energy use and an organisation's overall carbon footprint, including, but not restricted to, energyefficient heating and lighting solutions; waste management and recycling projects; and green transport plans. Entries can come from health or social care organisations and their industry partners.

#### **Entries must:**

- Give evidence of how this makes services more efficient
- Give evidence of what makes this initiative different from other offerings

### **BEST PATIENT SAFETY INITIATIVE**

This award reflects the current drive to improve patient safety across health and social care settings. It will be presented to a project in either the health or social care sector that can demonstrate measurable improvements in patient outcomes or a reduction in 'never events' and similar problems. This can include projects relating to key issues such as reducing pressure ulcers, cutting down on healthcare associated infections, reducing falls, addressing medication errors, etc.



This award will reward excellence within the primary and community care sectors, as well as acute care.

#### **Entries must:**

- Give a full overview of cost savings, time efficiencies and other measurable benefits
- Explain how they are helping to overcome issues with interoperability

On a process or admin side, this can be carried out by improving back-office functions such as staff rotas, expenses, ID authentication etc, improving estate management, enhancing cyber security, improving knowledge and training, etc
